- Assist in the supervision and training of Medical technologist 1, Medical Technology Intern and Technical Assistants
- Undertake routine and complex testing procedures in the various sections of the specialized department or laboratory
- Adhere to safety protocols of the organization ensuring health and safety of self, other staff and visitors
