## Summary:

Reporting to the **Chief Executive Officer**, the incumbent has direct responsibility for the daily management and administration of the hospital's activities in relation to the hospital's operations, thereby ensuring control and adherence to standards to achieve optimum quality health care delivery. The incumbent is also responsible for providing oversight to all paramedical services, medical records, and dietary services, within the hospital, with particular emphasis on departmental procedures.

- Participates in all Quality Assurance activities, and all plans to ensure Total Quality Management in the overall hospital operations.
- In collaboration with the Human Resource Administrator, interprets and communicates all Ministry of Health & Wellness' policies to subordinates, and assists the Chief Executive Officer in the implementation, and monitoring of policies and procedures of the hospital.
- Ensure that systems are designed within departments in order to create continuous flow of information and activities. Systems will be reviewed periodically to accommodate changes.
- Supervising the fixed asset/inventory officer and storekeeper and liaising with the Manager, Regional Inventory & Fixed Asset in ensuring that the fixed asset registry and inventory tracking systems are properly maintained and evaluating stock levels to improve inventory control procedures.
