#### **Summary:**

Reporting to the **Regional Director,** the incumbent will Identify, evaluate and analyze risks inherent to the operations of the facilities across the region and ensure that facilities maximize compliance with requirements (regulations, legislature, policies, procedures and standards) as well as stakeholders' value.

- Risk Management accreditation or certification.
- Project Management accreditation or certification.

- Coordinates risk management efforts among all functional areas of the region involving Directors, Parish Managers, Chief Executive Officers.
- Implements and enforces policies and procedures of the organization by way of systems approved by the Regional Director that will improve the overall operation and efficiency of the region.
- Conducts research and recommends changes to policies, procedures and systems to enhance the functioning of various units and Departments throughout the region.
- Assists with the preparation of the Region's Annual Returns, Strategic Plan and Operating Budget.
- Examine emerging trends in the health sector (nationally, regionally, internationally) that could impact the region and provide feedback to the Regional Director accordingly.
